IF VIOLATION IS AT SUSPENSION STAGE, ONLY CASH, MONEY ORDER, OR CREDIT CARD WILL BE ACCEPTED. PAYMENTS MAY BE MADE AT THE VIOLATION BUREAU EITHER BY THE VIOLATOR OR HIS OR HER REPRESENTATIVE.

VIOLATIONS MAY BE PAID BY CREDIT CARD OVER THE PHONE BY CALLING GPS AT 1-888-604-7888. A SERVICE FEE IS REQUIRED.

FINES, COSTS AND/OR FEES COLLECTIBLE AT THE VIOLATIONS BUREAU MAY BE REVISED AT ANY TIME UPON ORDER OF THE PRESIDING JUDGE.

THE STATE'S JUSTICE SYSTEM FUND FEE OF \$40.00 IS INCLUDED IN THE FINES, COSTS AND/OR FEES WHERE APPLICABLE.

UPON DEFAULT, AN ADDITIONAL FEE OF \$35 SHALL BE ADDED. A PERSON WHO FAILS TO PAY A IN FULL WITHIN 56 DAYS AFTER AMOUNT IS DUE AND OWING IS SUBJECT TO A LATE PENALTY EQUAL TO 20% OF AMOUNT OWED.
