## CITY OF WAYNE DDA MEETING MINUTES 10-9-19

Mayor Rhaesa performed the Oath of Office for Walter Bender, new Board Member.

Chairman Steinhauer called the meeting to order at 6:04 p.m.

A motion was made by Gocaj and supported by Law to approve the agenda. Motion carried unanimously.

A motion was made by Gocaj and supported by Demmer to approve the minutes of the October 9, 2019 meeting. Motion carried with Bender abstaining.

A motion was made by Gocaj and supported by Rhaesa to ratify payment of the following bills: City of Wayne Water bills; \$46.08, \$157.92, \$157.92, \$98.19, \$98.19, \$39.48, \$39.48, \$88.84 and 139.74, Italy American Construction, \$11, 195.00 Motion Carried Unanimously.

A motion was made by Gocaj and supported by Demmer to approve payment of the following bills; Wayne Main Street \$10,000.00 and Highland Landscape \$4,725.00. Motion carried unanimously
